The bank further agrees that the Competent Authority shall have the fullest liberty, without the consent of the bank, hereunder to vary any of the powers exerciseable by the Competent Authority against the Promoter/Estate Agent or to grant extension in time and to forbear or enforce any terms and conditions of certificate of registration and bank shall not be relieved from its liability by reason of such variation or extension being granted to the Bank or the Promoter/Estate Agent or by any matter or thing whatsoever which under the law relating to sureties would, but for the provision have effect of so relieving the Bank.	
The bank lastly undertakes not to revoke the guarantee during its currency, except with the previous consent of the Competent Authority in writing, and the liability of the Bank under this guarantee shall not be impaired or extinguished on account of any change whatsoever by any manner and irrespective of any contestation regarding claims and disputes, the bank shall deposit the guarantee amount on first demand of the Competent Authority.
